



Unified Showmanship

1. This event is open to all special needs individuals 9 years or older. They **do not** have to attend or live in GCCISD boundaries like stated in the Baytown Youth Fair (BYF) Rulebook.
2. The special needs individual “athlete” will be paired with an FFA/4-H Member “buddy” and show either a lamb or a goat, during the 2023 BYF.
3. Athletes are not required to provide a lamb or a goat.
4. Each athlete is required to attend 3 of the 4 practices. If can’t attend due to another Special Olympic event must bring note from coach.
5. Each buddy is required to attend 3 of the 4 practices. If can’t attend due to another commitment must bring a note from person in charge.
6. Closed toed shoes are required at all practices and during the show for both athletes and buddies.
7. During the show the athletes and buddies are to wear their provided Unified Showmanship shirt, long pants and closed toe shoes.
8. Each athlete/parent or legal guardian is required to sign a liability waiver on or before the first practice.
